January General Meeting January 11, 2020

The January meeting began at 9:00 a.m. with Club business the first item on the agenda. When Past President Don Milburn related his exchange with medical personnel about Beads of Courage, our demonstrator for the day told us that two of their children had been patients at the NICU and received Beads of Courage.

Program Director Dave Madden introduced Michael Alguire, who is from New Mexico. Dave first saw Michael at the Rocky Mountain Symposium, where he demonstrated his <u>Wheels of Delicacy</u>. Dave told us that Michael would show us the many steps required to create this award-winning object.



Michael turned two half-wheels, making sure the sides were 1/8" thick, matching the two pieces by grain



if possible. He then glued the two wheels together and used hot glue to fasten small dowel sticks around the circumference as a clamp to hold the two pieces until they dried.

After a break for lunch, Michael deemed the glued pieces sufficiently cured, and proceeded to twist off the dowel sticks. Any glue remaining was scraped off with a pen knife.

When asked how he priced his pieces for sale, his reply was, "Not by the hour!", since it can take 300 hours to create one of the <u>Wheels of Delicacy</u>, but that the cost of the material and the size of the finished piece are factors.

From this point, the steps are as follows:

• draw the entire pattern, keeping a 1/8" distance from edges

- wood burn the pattern
- pierce the pattern
- add color

When he was about to begin piercing the wheel, Michael explained that he ALWAYS wears a respirator when piercing, and makes sure there is fresh air as well. He said that piercing the interior diameter is most difficult, so he chooses to do that first. It became apparent that it would indeed take many hours to pierce the entire wheel!



February General Meeting February 22, 2020

This all-day meeting began at 9:00 a.m. with a welcome by Vice President Ken Allen. Ken quickly went through Club business, then called upon Program Director Dave Madden, who introduced our guest turner, John Beaver. John has many published articles and has demonstrated throughout the United States and around the world.

John told us that he planned to demonstrate four different things today:

- 1. Basic/easy Wave Bowl
- 2. More Complex Wave Bowl
- 3. Flying Ribs
- 4. Bangles

John related that he began turning in 2009. By November 2010 he decided to do woodturning full time. He was advised to concentrate on a signature item, which became the Wave Bowl. He presented a slide show of his various works.



Beaver began his demonstration by illustrating the first cut to a square block of wood. He moved between the lathe and the band saw, showing the various steps needed. He showed his circle-cutting jig, and cautioned folks to take their time, feel comfortable, and - breathe. A microwave was another tool used during his demonstration. This allowed him to steam-fit the thin piece that would extend beyond the bowl.

After our lunch cone-shaped base. would become six take and drew that procedure from that



break John demonstrated Flying Ribs, using a He made three cuts to the cone shape, which ribs. He decided the shape that the ribs would on a blank rib before cutting it out. The point was cut - glue - dry - repeat.



Beaver then began his demonstration of bangles. He showed slides of the many designs he uses in the bangles he sells. He referred us to his website: www.johnbeaver.net, where he has posted the various sizes of bangles. His demonstration showed options and design opportunities.

Because he had encouraged questions all day, there were

only a few more as he brought the meeting to a close. The nearly 40 members who attended impressed John with their pertinent questions, and the members were unanimously impressed with his presentation.

PAW Scholarship for 2020

Prescott Area Woodturners are pleased to again offer a scholarship toward training anywhere in the country. The rules for this award are listed in the By-Laws, Policy #4, as follows:

Policy 4. Members Scholarship Program.

Section1. Purpose: The purpose of a scholarship program for the membership of P.A.W. is to embrace the personal skills in woodturning, which includes, but are not limited to form design, wood selections and finish including embellishments and tool techniques.

Section 2. Eligibility: The scholarship program is limited to the membership of P.A.W. requiring a member to be in good standing in the club for a period of two complete years. At the end of each calendar year the board of directors will determine if a scholarship will be given during the upcoming year. The board of directors will confirm to the membership by March 1st if a scholarship will be offered for that calendar year. The decision will be based on membership head count which must be in excess of 50 members. The dollar amount will be a base of \$400 or 16% of membership fees for that year. A maximum of \$500 will be awarded.

Section 3. Applicantion Requirements: The scholarship will be offered yearly to one member. The member must present in writing a request to the board no later than May1st as to the program they wish to attend. The request would include: name of program; instructor; location of event; total cost with a breakdown of class cost, transportation, and living expense. No scholarship will be awarded until after May 1st, giving everyone a chance to make a request to the board.

Section 3-1. A scholarship recipient must have shown an interest in woodturning through the purchase of basic equipment and display in public his or her work. Suggested displays would include Instant Gallery at meetings, display of work at local establishments, and club sponsored sales.

Section 3-2. Each scholarship recipient must be willing to demonstrate to the membership at a stated meeting the skills learned so that all members will benefit in some way from the scholarship.

Section 4. Selection Process. The board will select one member to receive the yearly scholarship with an alternate also selected.

Section4-1. The board and the scholarship recipient will agree how the dollar amount shall be applied toward the tuition.

Section 4-2. The board will select a member for the scholarship based on established criteria. Should a board member be a candidate for a scholarship they will not be in attendance during the selection process.

- Be a guest in someone else's studio. We will pair you with another juried artist if you don't know someone.

We encourage artists to share studio space whenever possible, as Tour studios with more than one artist receive substantially more visitors.

As a Tour artist, you will:

- Have your own page on the Tour website.
- Have one of your images featured in the Tour brochure which goes to 15,000 people and on a Tour poster.
- Be included in our social media and print advertising campaigns.
